The site is publicly available to all Internet users. As part of the Website, the Administrator runs an online press service of the ORSAY brand, under which he provides news, press releases, photos, presentations, lookbooks, brand history and downloadable materials for publication purposes related to the ORSAY brand (hereinafter referred to as: „**Materials and Information**“). The Press Room is addressed mainly to magazine and portal editors, stylists, bloggers, all promotional materials producers, but also to anyone who will need promotional materials made available through the Website.

The Materials and Information available on the Website may be used by downloading them or making them available for further publication in the media of users or their partners. The use of Materials and Information available on the Website is free of charge, unless other information is contained on the Website. The use of the Materials and Information is authorised under the condition that they are used in accordance with their intended purpose and that they are marked in a clear and visible way as belonging to ORSAY. The person using the Materials and Information is also obliged to observe the period of copyrights and their admissible areas of publication, to which the Administrator and its affiliates have the right - in this respect if there are no other conditions in the description of the Materials and Information, the following terms and conditions should be accepted as default:

1. The User is not entitled to use the Materials and Information made available on the Website on TV (television) and OOH (out-of-home);
2. Materials and Information - product images - the user can use them unlimitedly in terms of time, media type and region;
3. Materials and Information with models (in particular photos, videos and lookbooks): acceptable time of use is 4 months from the first publication (information about the final date of publication is specified by the Administrator for a given Material and Information, and in the event of its lack the user is not entitled to use them longer than 4 months after their use) and the acceptable type of media is: press and online.
4. Area (except for product images): only markets on which the ORSAY brand is present, including ORSAY franchise markets.

ELECTRONIC SERVICES ON THE WEBSITE

The following electronic services are available on the Website: photo download form and newsletter. The use of these services is voluntary and free of charge.

PHOTO DOWNLOAD FORM

This is an interactive form available on the Website that allows the user to choose from the Materials and Information available for download, to specify their parameters and to download or generate a link to the photo package. The use of the form starts when the first photo is added to the virtual basket and ends when you download the photos or finish using the form.

The use of the form is free of charge and does not require providing personal data.

NEWSLETTER

It is an electronic distribution service provided by the Administrator via e-mail, which allows all users to automatically receive from the Administrator cyclical content of subsequent editions of the newsletter containing information about new Materials and Information on the Site, news on the Website, information about new collections, products, campaigns, cooperation with celebrities, or other events organized by or related to the ORSAY brand to the e-mail address provided by them.

The use of the newsletter begins after completing a total of four steps: (1) entering the user's email in the tab / box regarding the newsletter available on the Website, (2) selecting the region from the regions available in the subscription form, (3) clicking the action field and (4) confirming the newsletter subscription by clicking the confirmation link which is sent to the provided email address - at this moment the user is subscribed to the newsletter. The Administrator can also subscribe the user to the newsletter directly, after obtaining the user's consent.

The use of the newsletter is free of charge and requires the user's e-mail address and selecting his region from the regions available in the subscription form.
